Sub: **Standard Operating Procedure (SoP) for providing wage employment under MGNREGS to the migrant workers housed in various Temporary Medical Camps (TMCs) of the State.**

Ref: **This Department letter No. 7752 dated 23.04.2020.**

Madam/Sir,

Due to COVID-19 induced lockdown, a large number of migrant labourers working in different States have lost their livelihood and are compelled to return to their respective villages. As per Health & Family Welfare Department directives, these migrant workers who have been returned from other States are to be kept in institutional quarantine for 21 days in various Quarantine Centres/ Temporary Medical Camps (TMC) of the State.


In order to secure the livelihood of these returnee migrant workers, it has been decided to provide wage employment under MGNREGS with strict adherence to the quarantine norms prescribed by Health & Family Welfare Department.

- 1. Issue of Job Card:** All quarantined migrant workers willing to do unskilled work & not having Job Cards shall be issued Job Cards immediately. In case any of them not having a bank account, the bank account shall be opened through Business Correspondent of Banks. Aadhaar Seeding and ABPS Conversion shall be done simultaneously.
- 2. Provision of Work:** All willing workers in one TMC shall be provided with work on the premises of the same TMC.
- 3. Nature of Works:** The following categories of works shall be taken up preferably in the premises of Quarantine Centres/ Temporary Medical Camps (TMC) or near-by.
 - i. Land Development/ Landscaping/ Land Levelling etc.
 - ii. School Boundary Wall

- iii. Development of School Playground
- iv. Recharge pit near Tube-well
- v. Plantation Activities
- vi. Multi-utility tank

4. **Precautionary Measures:** In addition to the social distancing and precautionary measures prescribed in the SoP communicated vide this Department letter No. 7752 dated 23.04.2020, quarantine norms prescribed by Health & Family Welfare Department shall be strictly adhered to. No work shall be taken up in violation of instructions communicated by the Government in the Health and Family Welfare Department.
